





HOW TO SET UP

- 1. Connect the Streaming Arcade Console to a TV or monitor via the included HDMI cable*.
- 2. Use the included Micro USB AC adapter* to power the Streaming Arcade Console.
- 3. Power on the Control Top.
- Press and hold G Home/Menu button on the Control Top for 3 seconds until the LED indicator starts quickly flashing.
- 5. Press the pairing button on the Streaming Arcade Console and the pairing window will display on the screen. The pairing button scrolls through options when briefly pushed twice in rapid succession. A single push on the pairing button selects an option.
- Press the pairing button and select [Control deck P1]. Long press the pairing button to confirm the P1 pairing. Repeat this step and select to pair [Control deck P2].



*Note: USB Charging and Data Cable (5ft); HDMI Cable (1ft); Micro USB AC Adapter Cable (5ft) are included.

HOW TO CHARGE MY CONTROL TOP

Before the first use, please connect the Control Top to the provided USB charger* (Output: 5V/2A) or a computer with the provided USB cable until it's fully charged (battery indicator light will turn off). Subsequent full charges should take approximately 5 hours.

*Note: While some compatible USB devices may be able to supply power to the Control Top, AtGames cannot recommend any particular device. Please follow the instructions on the third party charger.

QUICK START GUIDE

All screenshots shown are for illustration purposes only. Actual screens may vary.

- 1. Power on both the Streaming Arcade Console and the Control Top.
- Use P1 joystick to select and play 150 pre-loaded games. (Note: Internet connection is not required. The games can be played offline.)
- Connect internet via Ethernet (Ethernet cable is not included) or Wi-Fi to play more games on ArcadeNet®.
- To connect through Wi-Fi:
 4-1. Select [Wi-Fi] under the [SETTINGS] page.

4-2. Select the Wi-Fi SSID you would like to connect to, and select [Connect]. If prompted, enter the Wi-Fi password using the on-screen keyboard and select [Submit] when done.





HOW TO UPDATE FIRMWARE

- 1. Power on both the Streaming Arcade Console and the Control Top.
- 2. Connect internet via Ethernet (Ethernet cable is not included) or Wi-Fi.
- 3. Go to [SETTINGS] and select [Version].
- If there is a newer version, follow the instructions to download the latest firmware. Make sure the internet connection is stable during this process.
- 5. Once the firmware is downloaded successfully, select [Upgrade] and the device will reboot automatically to activate the new firmware version.

HOW TO SIGN IN WITH YOUR ARCADENET® ACCOUNT

- 1. Go to [SETTINGS] and select [SIGN IN].
- 2. Sign up for a new account if you don't have one yet.
- Once you have an ArcadeNet® account, you can choose either to sign in with your email or with the QR code. To sign in with your email, enter the email address and password.






- 4. To sign in with the QR-code, a smartphone is required.
- 5. Use a smartphone to scan the QR-code on the screen to launch the ArcadeNet® website. You will be directed to the login page, where you can choose either to sign in with your existing Google/Facebook account or your e-mail.
